1. APPROVAL OF MINUTES

Motion made by Ralph Money to approve the November 2025 meeting minutes. Seconded by Issy Caporale. Motion carried 5-0.

2. PUBLIC COMMENT - None

Motion by Chair Dornfeld to move the first item of new business after public comment in consideration of Cpt. Durling's time. Seconded by Issy Caporale. Motion carried 5-0.

A. Division of Professional Standards Annual Report

- **B.** Written Correspondence Chair Dornfeld shared an email from Rudy Marconi requesting input from the Police Commission regarding the criteria/qualifications to be used as the BOS prepares to interview individuals for the new Public Safety Facility Building Committee.

After some discussion, Ralph Money made a motion to request a joint meeting of the Board of Police Commissioners and the Board of Selectpersons to discuss next steps regarding the Town's future public safety facility needs moving forward. 7. CHIEF'S REPORT

- A. Traffic / Sign Report Submitted by Sgt. Matthew Seibert
 - Parts have been ordered for the malfunctioning sign on Rte. 116. The State will come repair it once the parts arrive later this month.
 - The Rte. 7 speed sign is also malfunctioning due to poor battery charging (weather/winter/high traffic volume). The state is aware and is going to come evaluate the issues.
 - UCONN's T2 Center was contacted to request a vehicle counter on Prospect Ridge to evaluate a resident's concern over vehicle and pedestrian traffic reported last month. They will install a counter and report back the results once the data is collected.
 - The area of 432 Branchville Road was referred to State DOT to conduct a comprehensive review to determine whether any roadway or signage improvements are appropriate for this location.
