### Ballard Park Event – July 4, 2026

Dawn reported that Committee members need to step up and help as there are important logistical, as well as programmatic, needs that need to be addressed. In addition, Committee members should be on the lookout for other community members to help with this event, particularly those with some experience.

The Committee discussed the time for this event and are recommending it end at 2. Also, we are thinking that it not include a meal, but rather snack -type items such as hot dogs, cotton candy, popcorn, ice cream, etc. The possibility of food trucks on the adjoining street was discussed, as well as the necessity of obtaining approvals for street closing, etc.

#### Parade:

After discussion, it was decided not pursue the concept of a parade July 3, 2026. Committee thinks our efforts would be better spent on preparing a sensational float for the Ridgefield Memorial Day Parade.

#### Merchandise

We have been advised by the Town Treasurer that merchandise is not to be sold, although we can accept donations.
